

## ICT Policy

### Introduction

The purpose of this policy document is to define the principles and aims of communication at Melrose and the Pre-Preparatory Department and to provide a framework which;

- promotes consistency in school planning and school practice.
- facilitates development and change.
- informs new staff, pupils, parents, governors and the wider community.

### Principles

### Aims

Our aims for ICT are:

- that children will become independent users of ICT, gaining confidence and enjoyment from the ICT activities.
- the school will use ICT as a tool to support teaching, learning and management across the curriculum.
- to enable children and staff to select and use ICT tools appropriately and efficiently and apply their use across a range of subject areas.
- children will understand the importance of safety when using the internet.
- to ensure continuity and progression throughout the school.

### Strategies for the use of ICT

- all pupils will have a regular taught ICT input (integrated throughout the curriculum) with equal opportunity to develop their ICT capability.
- to ensure progression in the development of pupils' ICT capability, planning will be based on the ICT National Curriculum Programme of Study (Rising Stars).

- ICT will be included at all levels of curriculum planning to support, extend and enhance teaching and learning.
- ICT work will be differentiated by groupings, work set, provision of additional support and extension activities where appropriate.
- Teachers will look for opportunities to integrate ICT into different areas of the curriculum.
- pupils' ICT capability will be monitored and assessed according to the schools Assessment Policy.
- teaching and recording will be done through a variety of formats and styles.
- teachers will evaluate, review and continue to improve the effectiveness of ICT in their classroom.

### **Assessment**

Monitoring of the key aims of the National Curriculum will be conducted by teachers across the academic year using the resources from Rising Stars.

Feedback on other tasks as part of the curriculum will generally be given while the task is being carried out.
