We are looking forward to running a pilot for the AI for Youth Program next week. The program is part of a world-wide program that is being developed and led by an experienced trainer, Simon Johnson (<u>(17) Simon Johnson | LinkedIn</u>), from Tablet Academy and Intel. This is very timely and shows how The Ladies' College is taking steps to develop Future Ready skills. Simon explains: *"The Intel AI for Youth program is a comprehensive workshop designed to equip students with essential AI knowledge and skills that will shape their future. During this immersive experience, students will explore the cutting-edge field of AI and its significance in today's world.*

Through engaging activities and hands-on projects, students will delve into AI domains such as machine learning, computer vision, natural language processing, and deep learning. By immersing themselves in these concepts, they will develop a deep understanding of how AI is revolutionizing industries and driving innovation.

Please be assured that no student names will be used in full, and the school will see and approve the video before it is shared with any other parties.

A reminder that the arrangements for the days can be found in the letter sent by Mrs Gribben's earlier this week (meet in the Leaf Centre, 0825-1530 Monday, 0825 start on Tuesday, must bring charged devices and a charger please – recommend chargers and devices are labelled – and their headphones).

I do hope that you feel that you are able to give consent as opportunities such as this are important in being able to provide expert and relevant experiences to our students, as well as promoting the values of the College and addressing the gender imbalance in fields such as Artificial Intelligence, that will have long term impacts on a global scale.
